Your personal data is collected and processed on the basis of:

- Your Consent, given to us, to process your personal data for the purpose of contacting you, providing you with quotations, communicating to you company news, promotional offers and other information related to our business
- Operational & Contractual Requirements, for the purpose of entering into or performing any contractual agreement with you and fulfilling the contractual obligations arising thereof

- Legal Requirements, imposed by regulations in force, as for the purposes of notification and registration which MGV-Yachts-Cruises is obliged to perform in compliance with legislative conditions for concluding yacht charter agreements and related activities
- Other Legitimate Interest, as for the purpose of optimizing our product/service mix and our marketing activities to provide you with products/services and offers best-suited to your preference

What type of personal data do we collect?

Personal data is information that identifies you as an individual or relates to an identifiable individual. The collection of personal data is necessary to delivering our services to you and to enhancing your user experience. We guarantee that the amount and type of personal data we collect is at all times reasonable, necessary, and maintained to the minimum requirement imposed by criterion of necessity for operational and contract performance, legal requirement or other legitimate interest per level of interaction.

Please see below a detailed list of personal data we collect per level of interaction:

a) Contact and Inquiry Data

We may collect and process personal data you provide to us when contacting our company either via phone, email, social media, and newsletter subscription, one of the contact forms embedded in our Website, or offline through any representative of our company. Personal data recorded and processed by us might include your:

- Name
- Surname
- E-mail address
- Phone Number
- Any data included in the comments of your inquiry

Should you be contacting us through one of our contact forms embedded in our Website or once you subscribe to our newsletter, we additional receive your:

- Internet Protocol Address (IP address)

Should you place an inquiry for a specific service (e.g. chartering a yacht), we may also collect information about your holiday preferences such as:

- Yacht Charter Type (bareboat, skippered, or crewed)
- Yacht Type (monohull sailing yacht, catamaran, motor yacht, including the specific model and any related equipment)
- Yacht Charter Price
- Sailing Area
- Check-in / Check-out Date
- Other Specifications, including the number of guests on board, etc.

The reason for us collecting and processing those data is the legitimate interest to provide to you a meaningful response that is related to the purpose of your contact.

b) Website Browsing Data

We may process data about your use of our Website, also referred to as "usage data" in order to analyze the use of our Website and services. Usage data may include your IP address, geographic location, webbrowser type and version, operating system, length of visit, page views and Website navigation paths, referral source, as well as information about the timing, frequency, and pattern of your usage of our Website.

The source of the usage data obtained by us are cookies, web beacons, tags & scripts, logs, and other similar technologies and storage objects such as HTML5, used directly by us or by our service providers. Our main service provider for obtaining usage data is Google Analytics. Google Analytics gathers information about the usage of our Website by means of specific cookies. The data gathered by Google Analytics is communicated to us in Google Analytic Reports.

c) Other collected Data

We collect and process the following personal data from you in order to finalize a booking or charter agreement. Please also note that this information might be disclosed to parties being involved in the charter agreement (i.e. yacht owners and other intermediate agencies) and legal authorities (i.e. port authorities).

- Personal ID Data of the charterer, skipper, co-skipper, and crew members (mandated by law):

Name & Surname

Gender

Date of Birth

Nationality

Passport or ID card number or Scanned Copy of Passport or ID card (applicable to the charterer, skipper & co-skipper)

Residence Address and Email Address (applicable to the charterer only)

Mobile Number (applicable to the charterer only)

A scanned copy of the sailing license (applicable to the skipper & co-skipper)

Payment Data of the charterer

Tax Registration Number, required by Greek law (applicable only for Greek citizens)
Bank Account Details, obtained once transactions regarding the charter are undertaken

- Data related to travel arrangements (skipper, co-skipper)
 Flight details, local accommodation details, airport transfer details, etc.
- Data needed to offer a personalized service on board (if applicable)
 Dietary preferences and/or constraints, information about your health or any medical condition that may require special attention during your stay on board, etc.

What do we use your personal data for?

By accepting this Privacy Policy document, you acknowledge our policies and give us your consent to use your personal data for any of the following legitimate purposes, under applicable law:

Operational Purposes

We may use non-personal and personal data in order to provide and operate our services. This might include responding to your inquiries, requests, questions, suggestions, compliments, or complaints, complete any monetary transactions needed to complete a charter agreement or other booking, send you administrative information (e.g. change of policies or terms & conditions) or provide any other customer assistance or technical support to you.

Legal Purposes

We may process and disclose your personal data in order to comply with legal, statutory or regulatory obligations. For example, we need several of your personal data in order to:

- Prepare and enter a charter contract with you that is legally accepted
- Proof that our internal processes function as intended and comply with legal, regulatory, and contractual requirements in case of a company audit
- Monitor and prevent fraud and other security related issues (e.g. cyberattacks)

Marketing Purposes

We may use, process and/or disclose your personal data to third parties for marketing purposes. As such we might use your data to:

- Create aggregated statistical data and other aggregated or inferred non-personal information which helps us to provide or improve our respective services and design effective promotional campaigns that use optimized marketing tactics
- Contact you with general or personalized service related notices and promotional messages

- Allow you to participate in contests, sweepstakes or other promotions organized by us
- Subscribe you to our Email Newsletter or any other similar marketing activity (upon your specific consent)

How do we store personal data?

Like most other businesses worldwide, we use various third party services for our business operations that process and store your data on their own servers which might be located outside of the country you reside in or outside of the European Economic Area (EEA).

However, you can be ensured that we select those service providers with great care and make sure that they are reputable and trustworthy, like Google, Microsoft, Wix, and Dropbox.

All company accounts with the service providers mentioned above, are secured by a structured system of authorization and access levels and have unique access credentials that are only available to MGV–Yachts–Cruises staff.

Our Website is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to sell our services to you. As such, your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. All data is stored on secured servers, protected by firewalls.

Please be aware that although we undertake all reasonable measures to ensure the security of your data, we cannot fully eliminate all security risks associated with data information.

We will retain your personal data for as long as it is required to fulfill the purpose for which we collected it or mandated by applicable legislation and regulations (i.e. tax and accounting requirements, investigations / audits, or disputes).

It is important that any personal data you share with us is accurate and current. As such, we would like to ask you to keep us updated on any changes of your information.

Of course, you might opt-out from our marketing activities (i.e. newsletter and publications) at any time. If you decide to do so, you will no longer receive any marketing material from us. Nevertheless, your personal data that has been previously collected, will be retained for legal and legitimate purposes (i.e. if your personal data is pertinent to a previous service order).

To whom do we disclose personal data?

Sharing your information is strictly limited to serving legitimate purposes. MGV-Yachts-Cruises will under no circumstance sell or make your information available to any third party if not required for operational or legal matters.

Under this framework, we might share your personal data with the following third parties (on an asnecessary basis and limited to the minimum required for the purpose it is intended to serve):

- Service providers (IT/Cloud service providers, Web-hosting platforms, Analytics companies, Pay Per Click (PPC) providers, E-newsletter providers)
- Operational partners (i.e. yacht owners, yacht operators, yacht crews, yacht brokerage companies, charterbase operators)
- Competent authorities (i.e. port authorities, tax authorities, etc.)
- Other suppliers, who are required to provide goods / services to you that have been ordered through us (i.e. transfer companies, grocery/food delivery companies, special service providers, etc.)

Everyone working at MGV-Yachts-Cruises has received a comprehensive training on Data Protection Issues, thus has a good understanding of the potential risk and harm that can be created by unauthorized use or disclosure of your personal data.

Your rights to your personal data

In accordance with the data protection law you have the following rights:

- The right to access your data. Meaning, you might ask us for a copy of your data;
- The right to rectification. Meaning, you might ask us to correct inaccurate personal information about you;
- The right to erasure. Meaning, you might ask us to delete your personal data (possible if compliant with applicable legislations, laws, and regulations);

- The right to restrict procession. Meaning, you might ask us to restrict the processing of your personal data (i.e. do not use it for promotional purposes);
- The right to object processing. Meaning, you might object to the processing of your personal information;
- The right to data portability. Meaning, you might ask us to transfer your personal data to you or another organization;
- The right to lodge a complaint to a supervisory authority. Meaning you might complain about our use of your personal data;
- The right to withdraw your consent. Meaning, you can withdraw your consent to our collection, process, and disclosure of your personal data to the extent that the legal basis of our data collection, process, and disclosure is consent.
